PLEASE READ & FOLLOW ALL INSTRUCTIONS:

1. Please fill out **all** information on this sheet (**all** info must be provided in order to satisfy ATF requirements)
2. Submit application (via email to ffl@orlandogunclub.com or in person) to The OGC.
3. The OGC will send a copy of our FFL (via email) to the third party's FFL.
4. Transfer, shipping and tracking of inbound items are the responsibility of you, the third party, or their FFL.
5. Upon receipt of the inbound item, **The OGC requires 24 to 48 hours to process the transfer.**
6. Once the ATF required receiving process is complete The OGC will contact you to transfer your item to you.

WE NOT SELL OR TRANSFER FIREARMS TO NON U.S. CITIZENS WITHOUT THIS STATUS / DOCUMENTATION. NON-U.S. CITIZENS PLEASE NOTE - MOST WEBSITES WILL PROCEED WITH THE SALE OF A FIREARM REGARDLESS OF YOUR CITIZENSHIP / DOCUMENTATION, HOWEVER WHEN YOUR CITIZENSHIP STATUS IS DISCLOSED DURING THE PHYSICAL TRANSFER PROCESS, THE FIREARM WILL NOT BE TRANSFERRED TO YOU, AND YOU WILL BE SUBJECT TO THE TRANSFER FEE IN ADDITION TO THE RETURN SHIPPING CHARGES.
